PUBLIC FORUM

Laura Drennan, East Mill Street addressed the Board. Ms. Drennan has lived in her home since 1993. She inquired about work on the right-of-way along Mill. She claims the right-of-way is uneven. Residents are unable to mow the area and are parking in their yards. She is also concerned about safety of children in the area.

Andrew Bartashies – he has applied for an R-G license for a golf simulation business. The new business would be located in the former grocery store. Business would have a minimal food menu and gaming machines. Alcohol sales would be under 40%. Golf business would be open year round and menu could be expanded once business picks up.

Water & Sewer

Trustee Hendrickson – Committee met on July 21st. Three items to report:

- 1. Consumer Confidence Report is available on the website. Report reflects that the Village has high quality water.
- 2. Fire hydrant at Natick Circle is leaking and will have to shut water off in area to fix.
- 3. Public Works has been understaffed for quite some time; however, department will soon be fully staffed.

OLD BUSINESS

PUBLIC WORKS SUPERINTENDENT REPORT – James Foster

Water/Sewer

• Penacook water service has been moving slow due to Sparks and other duties. We expect to get back on it this week. Water line is proving difficult to locate.

- Installed meter on Old Timbers for irrigation service.
- Hydrant on Natick was hit by vehicle. Noticing during monthly meter reading. Water will have to be shut off. Residents affected will be notified.
- Installed water services for new duplex on Waterwheel.
- Received complaints of sewer leaking through manholes on Parkview. Upon investigation, a large blockage was discovered. Mains have been reopened.
- Received request for leak checks. Leaks found were inside the home.

Streets

- Bucket truck is due for inspection. Estimates are currently around \$5,000.
- Borrowed the Township's boom mower and finished cutting back the bike trail. Also cut trees back at the parks and cut at State and E. Main.
- Mowed on Maxheimer from Route 29 to Community Drive.

Parks/Property

- Block replacement has begun at the Comfort Station. Blocks have been removed; however, this has caused serious chipping of surrounding blocks, resulting is removal of more blocks. Secured the window missing blocks and reopened the comfort Station as it is now functional. Police caught the vandals.
- Doors of sheds at Community Park were kicked in. Police caught the vandals and new doors have been reinforced to prevent future incidents.
- Our large mower blew a hydraulic line. We borrowed Township's mower, which
 did not work well with our large cutting deck, snapping a few mower blades.
 Tractor is now fixed.
- The Vactor had some issues which we were able to fix and put it back into service.
- A large portion of our time was spent at Community Park in preparation for Sparks.

Training/Consideration

- Met with Tom Hampton (Hampton Equipment) on road patching equipment. Reaching out to other vendors also.
- Interviews were held to open PW Assistant positions. Provided the Board approves, both candidates have accepted the position offers and are going through the paperwork. One is expected to begin working on August 16th, the other August 23rd.

• LOCIS 8 – Work Order and Code Officer software is being trial run right now. It is not quite as we hoped and are seeing if we can make it work.

- Had two reports of "black water" in pools. I am in contact with homeowners about their intentions. Also a few "tall grass" complaints, as well as one complaint about a pond.
