**Public Works Superintendent** 

See attached report – highlights below.

- A. CWLP had water main break. They checked to see if Rochester would be okay if they needed to shut off water. Supt. Foster confirmed that Rochester would be okay. The situation has been resolved.
- B. New generator is up and running. Not quite 100% as electrician has a bit left to connect.
- C. LTE Cell read water meters slowly rolling out in the village. Currently about 1/3 of the Village has the option. The remaining 1000 units has a cost of about \$215,000.
- D. Camelot Tar and Chipped earlier and have now used the street sweeper. The concerned resident has mentioned how dusty the road is.
- E. American Excavating at the old Americo station tentatively scheduled for spring.
- F. Letters of Associate People on Project Play public works has addressed the major issues. More issues continue to be a problem.
- G. Code Officer information A complaint was filed about people parking in their yards. There is currently no ordinance about parking in yards. The complaint stated there was no obstruction to traffic or viewing of traffic or sidewalks. Supt. Foster is not sure what the next steps will be or when.
