# Water/Sewer

- Hydrant leak on Grove Park Drive repaired.
- Magnolia residents complained of slow sewer drainage. Mains were jetted.
- Mavis Sewer slide pipe has been jetted, more needed. Separation has happened at one of the residents between lateral and main. House on hill is experiencing settling. Kuhn sent a structural engineer to evaluate.
- Maxheimer water main loop is online. Petersburg also had included the attaching of the service lines for the houses adjacent. Those are also in. Applications from the Maxheimer residents have been filled out to connect to our water system and have been sent to CWLP.
- IEPA notified us of deficiencies to our water program. We are lacking a Nitrification Action Plan (NAP). A reply has been sent to IEPA along with a drat of our NAP.
- Resident on Walberta is having sewer issues. We have jetted the main in hopes it would help, but it doesn't seem to have done anything to the main. Resident has a weird situation that may be causing issue.
- Illinois Water inventory Program (IWIP) Survey has been completed for 2021.
- Meters at Bow and Arrow have been changed.
- We were contacted about sewer issues at the winery. Plumbers found issue in line on back of property.
- New locator has been delivered and put into service.
- Discussed sewage output to SCWRD. Their pumps hadn't shut off in days. We closed our lagoons, they noticed immediately.
- Two irrigation meters on Old Timbers installed
- Assisted with flow test for Carriage Crossing fire suppression.
- Walberta/Sherry water main project considered complete. There are still ditches to cut there and some sidewalks we are planning on addressing along Sherry.

#### **Streets**

• Sidewalk for North Walnut drainage project has been replaced. Petersburg is expected out this week or next for final grading and seeding. We also shaped the ditch at Katie Lane and North Walnut for a bit better drainage.

- Mill and Pleasant drainage project being done in-house has stalled due to supply issues for parts. Currently Pleasant is closed on the north side of Mill due to trench dug during investigation of situation.
- Potholes have been filled. Plan to do more this week.

# Parks/Property

- Picnic table at large pavilion was damaged and has been repaired and reinforced.
- During the last rainstorm, Deb's office had a leak. Suttons has been contacted. It seems Library might have a few leaks also.
- Flagpole at the "triangle" had a serious lean. Fixed now.
- Access road at the north end of Park Street was collapsing. 36" culvert was extended and road repaired.
- Bathroom stall walls in men's restroom at Ice deli have been replaced.
- Park bathrooms are open.
- Assisted with dirt at new batting cages.
- Contractor was selected for work at Wanless Park. Work included seeding after clearing.
- Pavilion at North Park getting finishing touches such as fascia.
