Planning and Zoning

Personnel and Finance

Trustee Zobrist – P&F met to discuss recommended hirings in the Department of Public Works and the Police Department. Committee also looking into pricing for computer software.

Streets

Trustee Hill – Several items discussed in committee, including the following:

- Committee approved recommendation to Board for the purchase of a new street sweeper.
- Village Engineer has solicited bids for gutter and pavement repairs to Guinevere Drive. Three bids received. Low bid of \$15,181.88 from Sangamo Construction Company.
- Letter being prepared to legislators requesting state funding for Village street repairs
- Village Engineer reports that the reconstruction project for East Main Street from State Street to Illinois Route 29 is scheduled for the next IDOT 2020 bid letting.
- Proposed an amendment to parking ordinance to regulate boat trailer parking on Villages Streets.

 Proposed introduction of new ordinance similar to Illinois state statute found in Section 9 of the Road and Bridge Laws prohibiting deposition of leaves and grass clippings on Village Streets.

Water & Sewer

Trustee Hendrickson – Items discussed at the January 29th committee meeting include the following:

- Received comments from landowners in the Grove Park subdivision regarding water draining from adjacent farmland into their neighborhood.
- Water efficiency report up to 19% due to water main breaks
- Informed Board the restrictor plate for the storm water detention system at the school's 29 campus is still not working and is causing water drainage issues on North Walnut.
- Committee considering installation of storm sewer system to address the North Walnut flooding issue. Should have some bids for system at next meeting
- Maxheimer Road loop line is a top priority for the committee. Water main to run along Maxheimer Road to connect with the assisted living facility's line.
- Melody Drive plan is to install a 4 inch main to serve residents on that street
- Next meeting will be February 19, 2020 at 7pm.

Water Distribution System

- 1/28 Water event at 17 Circle Drive. Radial Crack about 75% around
- 2/4 Water Event on Oak Street, between East Main and Mill Streets on west side of road. Radial crack about 50% around.

Sewer

- PW contacted IRWA to have their camera van inspect Eastgate subdivision for infiltration into the sanitary sewer system.
- Pump #2 at the primary pump station is not cycling properly. Pump being monitored weekly. High amperage observed when pump is running.

<u>Streets</u>

- Engineer to submit plans for ditching projects around town.
- 2/5 Plowed for 9 hours to clear snow from roads and salt roads.

Buildings/Grounds

Plan to remove excess dirt and rocks from dump site in the next few weeks.

VILLAGE MANAGERS REPORT

Deb Elderton – Informed Board the TIF District had a surplus of \$130,771.55 for tax year 2018 payable in 2019. The Rochester School District will receive about \$80,000 of the surplus. The remainder will be dispersed to Rochester Township, Rochester Township Road and Bridge, RFPD, SCWRD, Rochester Library District, LLCC and Sangamon County.
